#### Who are we

- Largest and oldest volunteer run charitable, nonpartisan conservation organization in BC
- Membership of hunters, anglers, conservationists whose aims are to protect, enhance and promote the wise use of the environment for present and future generations
- Individual club roots traced back to the 1890s
- Current membership is made up of over 100 clubs across the province totalling more than 49,000 members and growing
- Donate over 300,000 hours to conservation/stewardship work

- Should be managed to maximize the benefits to BCers
- Do not want to see fish, wildlife or other natural resources privatized
- These values are at risk






#### Total Natural Resource Ministry FTEs

#### Funding & Capacity

- Provincial budget has steadily increased
- Responsibilities for resource ministries have increased
  - By 2010 there were 21% fewer staff than 1984
  - We have lost more since but government does not report FTEs
- 1998-2011 functions other than health, education and social services more than doubled
  - Funding for renewable resource ministries reduced by 56%




#### Wild-Domestic Sheep


- Domestics carry bacteria which are foreign/fatal
- 1850 BH pop estimate NA 1.5-2M, currently 70K
- Results in pneumonia and death
  - Loss of all age classes and poor recruitment
- Chasm herd 110 to 28
- Spent hundreds of thousands on a farm-byfarm basis




#### Thompson Steelhead




#### Region 5 Resident Moose Hunters

Schedule A - Map of the Tsilhqot'in Territory




#### Latest Government Decision

- Transfer 100 bull moose (80 resident/20 g/o)
  - TNG shifting harvest to bulls
  - Regional recovery plan
- No consultation
- No long-term funding
- No changes in legislation/policy
- No real plan



#### First Nations Issues

- FOI
  - Gov't perception of public interest
  - Gov't strategy divide and conquer
  - FN partners





#### Managing to Zero

- Long-term declines
  - Mountain Caribou, Central interior moose, Thompson Steelhead,
    Adams River sockeye, Kootenay lake
  - Mule deer, elk concerns
  - Water sustainability/Habitat
- Traditional response: Take from Peter to pay Paul, change the regulations, maybe study it
  - Results: 0

#### Funding Models: Who Pays the Freight

- Public pay trade offs that result in loss in natural capital of watersheds and landscapes
- Developer pay avoid, mitigate or offset
  - BC Hydro
- Polluter Pay monitoring and enforcement
- User Pay Dedicated license revenue
  - Outdoor tax
  - Industry (logging, mining, heli-skiing, eco-tourism)

#### Science

- Set legislated objectives for fish, wildlife, habitat at the landscape level
- Increase frequency of inventory
- Manage habitat, access, all wildlife
- Create recovery plans
- Implement




## Social Support

# Approach

#### **Historical**

- Fish, wildlife, habitat in decline
- "Change the regulations"
- Staffing and capacity dwindling
- Take from Peter to pay Paul
- Fish, wildlife, resident hunters anglers not a priority

#### **Future**

- Decision Maker Education
- Need for increased capacity
  - Internal capacity and advisory
- Advocate for funding, science, social support
- Increase social value of natural (public) resources

- Status quo not working
- Move to a sustainable model for fish, wildlife and habitat conservation
- Engage membership, stakeholders, First Nations, decision makers
  - Recruit intellectual capital and leaders
